# About Whova - TDW's Online Conference Platform

Whova is a top-rated online conference platform with a name that is ambiguous to pronounce at first glance. Start by saying "Who," and you will get it right. It's an app with almost every option any group taking an inperson event online could wish for.

TDW has subscribed to Whova options that allow those who register for the Convention to:

- view the agenda when it goes live, with updates about Zoom links, speakers and workshops
- · see who else is attending
- · exchange messages with other registered attendees
- make nominations and cast their votes for state officers in real time

Whova will also automatically update the agenda on our 2021 Convention page at tdw.org.

After you receive confirmation of your <u>registration</u>, you can use the web app link in the confirmation message to sign up for your Whova account on your computer. Or you can download the free Whova app to your smartphone and sign up using your phone. Either way, be sure to use the email you used to register for the meeting when signing up for your account. Then any time you sign in to Whova, you will automatically be directed to the Convention conference space.

According to the Georgia Tech COVID-19 **Event Risk Assessment Planning Tool** accessed on January 7, 2021, at a gathering of 50 people there is a 36% risk in Burnet County and a 61% risk in Llano County that one or more individuals present will be positive for COVID-19.



It is timely, then, that January's guest speaker is Jack Franklin, MD. (pictured)

Dr. Franklin is a board-certified Family Practice Physician and has cared for the citizens of Llano and the surrounding area for over 20 years. In addition to his private practice Dr. Franklin serves as the Medical Director of the Llano County Health Authority. He has been responsible for the county's COVID-19 testing program under the guidance established by the Federal CARES Act. Dr. Taylor will speak about his experience treating COVID patients, the status of the vaccine rollout, and about his personal COVID journey.

Nominations will be accepted from the floor of the virtual Convention pending determination of the nominee's membership status and with the nominee's consent.



#### For President-Elect

Kassandra Elejarza of Alamo is a 4-year, founding member of the Rio Grande Valley TDW Chapter. She is currently serving her second term as TDW's Vice President. She has been the Precinct Chair for Hidalgo County's Pct 253 since 2018. In 2018 Kassandra also worked as the South Texas Political Director for the Texas Democratic Party. She is currently the Political Director for Cambio Texas and is the managing partner in Arena Analytics, LLC.
